Sir,

This has reference to NBA's letter of even number dated 20-03-2019 under which Masters of Computer Applications program offered by your Institution was granted accreditation for 2 years upto 30-06-2021 by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where MCA Program of an Institution was granted accreditation for a period of 2 years, the period of accreditation of the program shall be extended from 2 to 3 years subject to the condition that the program meets the essential parameters of the Pre-Qualifiers. The Pre-qualifiers submitted by **Maharashtra Education Society's Institute of Management & Career Courses (IMCC), 131, Mayur Colony, Kothrud, Pune, Maharashtra- 411029** have been considered in NBA. The MCA program meets all the parameters of pre-qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:
